ORDER SETTING TAX RATE AND LEVYING TAX FOR 2022

WHEREAS, at an election held on May 2, 2020, the Board of Directors was authorized to levy a maintenance and operations tax by the voters of the District; and

WHEREAS, the District may levy a tax on all taxable property in the District to provide for payment of expenses as set out in Section 49.107, Texas Water Code; and

WHEREAS, the tax rolls for the tax year of 2022 have been approved by the Brazoria and Fort Bend Counties Appraisal Review Board; and

WHEREAS, the Financial Advisor for the District has made a recommendation as to what the tax rate should be.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF BRAZORIA-FORT BEND COUNTIES MUNICIPAL UTILITY DISTRICT NO. 3THAT:

I.

The total tax rate for the year 2022 shall be \$1.50 per \$100 of assessed valuation, comprised of (i) \$0.75 for maintenance and operations purposes, \$0.50 per \$100 assessed valuation for utility debt services purposes and (iii) \$0.25 for road debt service purposes. The District's Tax Assessor and Collector shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said taxes shall be levied, assessed and collected at the rate of \$1.50 per \$100 of assessed valuation for 2022 as provided for in Chapter 49, Texas Water Code, and all other applicable laws.

II.

The taxes levied hereby shall be delinquent after January 31, 2023.

III.

This Order shall be effective from and after its adoption.

IV.

The President or Vice President is authorized to do all things necessary for execution of this Order; and the President or Vice President is further authorized to execute, and the Secretary or Assistant Secretary to attest, this Order on behalf of the Board of Directors.
